1. Vendor Access Guidelines

Word[®] document designed to establish a standardized partner access guideline with optional recommendations focused on health and safety of all.

2. Measuring Effective Relationships

Simple software program that offers a flexible approach for two strategic trading partners to define and measure the benefits of their strategic relationship beyond the traditional emphasis on pricing, compliance, and volumes.

3. New Product Introduction Management Tool

Software for the day-to-day management of the pipeline of new product requests, designed by value analysis professionals for value analysis professionals

4. Perfect Order

A new process improvement and 10-point measurement method for trading partners to improve transactional efficiencies.

5. 810 Transaction Toolkit

Designed to assist both healthcare providers & suppliers to collaboratively analyze and implement the electronic method for invoice processing.

Documentation of lessons learned about contracting methods, frequency of data exchange, contract expiration management, quality control of data, and formatting and content management
